#### Cash

- Receipts Now Include Case Type
  - The case type will print on a receipt after the case number and a space regardless of the length of the case number.
    - EXAMPLES: 24-000456 SD, 2543947846 OI, 25-7895 GC

#### Civil

- Case Entry Revised Edits Small Claims (SC)
  - Under normal circumstances, the **Prim Atty** field does not display on the *Case Entry* (CAS) screen if case type is SC.
  - If an instance occurs where a case is entered with a case type other than SC, attorneys are added, and the case type is changed to SC, the **Prim Atty** field will display as highlighted.
    - This allows the court to remove the bar number in the Prim
       Atty field. Once the value is removed, the field will be hidden for the SC case.
  - To remove an Additional Attorney if a + indicator is present next to the Prim Atty field, use F8-Add' Attys to access and remove.
- Case Information Report Generator
  - A program bug of skipping and omitting a case number which did qualify based on using option I (Print and include the item only when a match is found) with an **Event Code** has been corrected.

### Forms – Updated

Corrections and updates have been made to the following forms:

- MC 26 Notice of Intent to Dismiss for No Progress (6/17) (NOI)
  - Form will now only print as an AFP version. The printer out queue being used must be in the AFP/HPT Maintenance table (accessed via ADMIN login).
- MC 230 Motion, Affidavit, and/or Order to Show Cause (1/24) (SCS) (Civil Only)
  - The **Judge** signature **Date** on page 2 was incorrectly populating with the hearing date instead of the current date. This has been corrected.

### Traffic/Criminal

- Transfer Screen and System File Inquiry & Update Screen Edits
  - New edits put in place to prevent the transfer of a case to an invalid court location.
  - An error message will display "INVALID NEW COURT LOCATION ENTERED" or "SYSTEM RECORD NOT FOUND FOR THIS COURT LOCATION" when an invalid value is entered.
